Item 1: Welcome, introductions & Executive Sponsor update

Ron Helmhold welcomed everyone and introductions were made. Ron updated on AWCBC Executive expectations for this committee, primarily the KSM Review.

Item 2: Review of Agenda and Previous Meeting Minute action items

Agenda was reviewed with no changes. All action items from previous minutes are ongoing or complete.

Item 3: KSMs – Committee Work Plan – Review Status

The statuses of the committee work plan items were reviewed and updated.

Items 4: Actuarial Update

Stan Warawa from WorkSafeBC and Chair of the CIA Committee on Workers' Compensation (CWC) gave an update on CWC activities. See presentation.

CFOs are recommended to speak to their own actuary who sits on the Committee for Worker's Compensation (CWC) about the Latent Occupational Disease Liability (LODL). A key component of the research project is anticipated to include guidance on which diseases are considered latent occupational diseases. The CFO Committee suggests that CFOs review the research project draft recommendations in case it varies from their own calculation of LODL

ACTION ITEM: At May 2014 meeting, review research paper and have each jurisdiction submit their latent occupational disease categories to see how existing practice lines up with the research project guidance.

Item 5: IFRS Working Committee Update

Laurent Charron updated on the work of the IFRS Working Committee and its meeting in Halifax. See presentation.

Item 6: IFRS / Accounting Update

Neil Parkinson, KPMG updated on IFRS and accounting issues and went through his paper, *The New IFRS Insurance Accounting Proposals: Implications for Canadian Workers Compensation Boards* (attached as meeting materials).

Item 7 – KSM Review Subcommittee Update

Ann Schultz presented the results of the KSM Review survey and outlined a process for review recommended by the KSM Review Subcommittee.

Voting process: It was agreed that the voting process would be a simple majority vote however it was acknowledged that the Committee will implement a process whereby jurisdictions voting against the majority have an opportunity to present a case as to why the KSM needs to be maintained. Final decisions on inclusion or exclusion of KSMs rests with the AWCBC Executive Committee with the CFO Committee's responsibility to provide recommendations with sufficient rationale.

ACTION ITEM: CFOs to take this list back to their jurisdiction and be prepared in May 2014 to indicate for each KSM if they want to keep the measure and whether it should be internal or external.
