

5) COVID-19 update: volume, claim management, impact on RTW, treatment, other challenges?

Since the beginning of the Covid-19 pandemic, The CNESST has treated 30 989. Even though there were many alleviations related to claims admission especially since January 2022 date at which the PCR tests were restricted to a group of employees, we are still on a plateau.



The major impact related to Covid-19 claims is related to long Covid cases. There is a difficulty in determining with medical certainty the long Covid diagnostic. Moreover, there are no specific programs for these cases. We are still exploring the best practices and relevant solutions in order to manage the situation.

6) Psychological injury update: volume, claim management, impact on RTW, treatment, other challenges?

There is a little increase in the number of psychological injuries in the CNESST since 2018.

2018: 3 595

2019: 3 897

2020: 3 889
