# **AOC NWISP System Enhancements**

Since we last met

#### **NWISP Submissions**

#### Completed

- Reduce submission processing lag time in Data Check and submission. Increase frequency to hourly instead of overnight. (requested by submitters at NWISP meeting)
- QA enhanced jurisdictional weightings for flagging year over year comparisons
- Changed wording on Data Check tab to make "select a year" clearer (request from Mary)
- Ability to download NWISP Submission checklist to Excel
- Data Check: Fixed issue with showing double entries when a submission year had been retracted.

#### In testing/development

- QA Add notification summary to submitter if data falls outside of thresholds; Add last year's values in Summary tabs to quickly compare prior years values.
- Adding new Occupation (NOC) Standard NOC 2011

#### Scheduled / Potential

- QA For KSM/NWISP check, check KSM numbers against numbers in actual NWISP submission, not numbers in manual summary
- Add NOC 2016 Standard
- Add new NAICS standard.

# Coding Manual:

#### Completed

Added ability to resize Coding Manual on screen to maximize view.

#### In testing/development

 Ability to update Secondary Source attachment without publishing an entire new version of Coding Manual.

#### Scheduled / Potential

- Add one General Search Field that searches all other search fields (Alpha Index, Includes, Code name, etc)
- Ability to expand bookmarks for navigation in Table of Contents
- When a Coder Note is added have it reviewed by the CTC before it's added to the Coding Manual.

- Increase font size of Alpha Index when downloaded/printed.
- Remove duplicate English entries in Alpha Index (when French has multiple entries).
- Add place to keep list of potential new codes.
- Fix bullets not showing
- Adding Secondary Source as part of the online Coding Manual (instead of as a separate PDF attached to the Coding Manual)

#### Issues

#### Completed

Increased size of dialogue boxes

#### Scheduled

- Add "NWISP Committee" as status
- Identify in notification if User has already commented on issue.
- · Add place to keep track of potential new codes list

#### Invalid Code Combinations

#### Completed

• ability to download as .csv file

#### In testing/development

- Improve search and make more user friendly.
- Ability to add invalid code at 1- 2- 3- of 4- digit level and have invalid code combinations propagated to 5-digit codes underneath. Only send out one notification for all codes together, not one notification per 5-digit code combination.

## Completed

- Functionality repair
- Correct answers not showing as correct. Incorrect answers not showing as incorrect.
- Bullets not showing.
- Table grids not showing.
- For multiselect and singleselect questions, text was cut off.
- Show All default on homepage to see all Modules.
- Improve user-friendliness of "matching" questions.
- Dropdown menu heading didn't lead to Coder Training.
- Change wording when question answered incorrectly.

## Coding Exercise:

#### Scheduled / Potential

- Adding French text (or vice versa) not required. Only one language required.
- Keep jurisdiction name when moving suggested cases to exercise cases.
- Create list of suggested questions page.

#### Completed

- Hide small values (data suppression) for public version.
- Added bookmarks for navigation to tables
- Removed secondary Table of Contents
- · Changed notification to match publication year

#### Scheduled / Potential

- improve table formats for readability.
- Tables available in Excel format.

#### **NWISP Data Extraction:**

#### Scheduled / Potential

- improve user friendly formatting
- removing hyperlinks
- · removing merged cells
- changing footer
- naming tabs
