1. Terms of Reference

Review revised Terms of Reference

2. Definitions

- In general, reword definitions where possible for easier readability/clarity.
- For jurisdictions that don't adhere to definitions (PDs, IJA, etc) why don't they, can
 anything be done so they can, can definitions change to include more jurisdictions, etc.
- Reference Periods: Should Fatalities and LTCs have the same reference periods? E.g. make LTCs "accepted" in year, not occurring in year and accepted for payment in year (or 3 months following), i.e. like fatalities.

a) IJA Claims

Are IJA claims included in NWISP data?

b) Lost Time Claims and Permanent Disability

 Are PDs that receive compensation included as LTCs per definition (e.g. SK, ON, NS, NL)

c) Lost Time Claims that become Fatalities

- Does everyone report per definition now?
- Do we still need the caveat for underreporting of fatality/LTC combos?

3. No Lost Time Claims

Do we expand NWISP to include No LTCs?

4. Coder Training

- Review online Coder Training in general.
- Haven't received much feedback, but some that there could be improvements.
- There was a request to make online Coder Training a searchable/downloadable manual.

5. NWISP Reporting

- Review NWISP reporting in general.
- Do we expand Age categories (over 65, under 15) for publishing?
- Extraction tool. Make it more user friendly. Promote to WCBs. Do we allow non-WCB users to pull their own data (either for a fee or at no charge)?
- NWISP Publication. Are current tables included in publication still correct tables?
- What summary tables should be provided free to public?

6. NWISP Publication – Review Revised NWISP Intro

The Committee will review the publication intro at the annual meeting, which includes confirming the following:

- Are IJA claims included in NWISP data? (Pieter to touch base with NWT and remaining jurisdictions)
- Are PDs that receive compensation included as LTCs per definition (e.g. SK, ON, NS, NL and NB (what year))?
- Do we still need the caveat for underreporting of fatality/LTC combos?
- Do we still need the caveat about Saskatchewan's conversion issues?
- What standards does everyone use for NWISP/Industry/Occupation?

7. Ad hoc Public Requests

- Cost:
 - o Do we continue to charge for data?
 - O What's the correct cost structure?
- Analyze requests
 - o What data is being requested?
 - What data are we unable to provide?
 - o Who's requesting the data?
- Is hiding values of 3 or less for non-WCB users the correct amount to hide?

8. Standards

- What standards does everyone use for NWISP/Industry/Occupation?
- Reassess current standards of SIC/NOC being used. Do we move to newer standards?

9. Submission Checklist

- Review and discuss submission checklist responses for comparability issues.
- Should current checklist questions be revised?

10. Coding Manual / CSA

 Now that AWCBC owns the CSA Standard, what do we make publicly available? What should that look like?

11. Footnotes

 Do we add NWISP footnotes (like KSMs), for example for new codes or for jurisdictions that don't include PDs, etc, so it's attached to the data/codes when pulled to help identify potential differences between definitions/jurisdictions, etc.

12. Review of Variables:

- a) Age categories (over 65, under 15)
 - Do we expand Age categories (over 65, under 15) for publishing?

b) Gender:

• How is gender coded? Biological sex or gender identified?

13. Codes

 Are all of the following codes required: Unknown, Unclassifiable, Not Coded, NEC, UNS, etc? Can any be amalgamated? (from external review of the publication intro)

14. Equivalent Terms

• Review required. What is 'Equivalent Terms'? How is it used? What should be done with it?

15. RFCs (enhancements to AWCBC's Online Data Community)

- a) Review recent and current RFCs
- b) Does Committee have any suggested enhancements?

16. Yukon Lost Time Claims

• First years show value of zero – should there be a note explaining?

17. Coding Targets
