With the support of AWCBC and its member organizations, Threads of Life has spent the past two decades creating and delivering programs and services to fill those gaps, at no cost to any family member – peer support, the opportunity to learn healthy coping skills and also the chance to be a voice for change. This two-part mission – supporting families in their challenges today, and working for a tragedy-free future – has always resonated with our partners as well as with our family members. But where do we find ourselves now, after 20 years? What has changed about that gap, about the ways in which your organizations work to support families? In this presentation, Threads of Life Executive Director Shirley Hickman will discuss the tragedy that set her off on this journey, and what Threads of Life envisions in the next 20 years of hope and healing.
